

A.G.M. TREASURER'S REPORT 27th August, 2018

Income 2017/2018

57% Fundraising

26% Sponsorship

17% Donations

Congratulations to Lynne Rawson on her fundraising and Denise Roscrow for her selling abilities.

Sponsorship has provided 26% more income than the previous financial year, however we have a 73% drop in donations from the previous year. In 2017/2018 we made 16% more in our fundraising mainly due to the function that was held at Flourish on King William Road, which made a profit of over \$5000!

Students Costs have remained very similar to last year

68% Accommodation and Living cost.

29% Education

3% Medical.

Hopefully the accommodation and living expenses costs will be reduced this financial year with the assistance of our new N.G.O. Canopy Nepal.

FONA'S administration costs are kept to the minimum. Our Facebook site and Website have been updated and which has increased our profile and hopefully in the future we will be able to sell our Nepali goods through these sites.

This past financial year has been interesting and challenging in so many ways. They say that it is a dull day when you don't learn something new – how very true. I have been dragged into the 21st Century of accounting with the help of Ken – who despite what others may think is a great teacher. However I can't say that I have been a great student.
